- Name - We may collect your name through our online website
- Email Address - We may collect your email address for correspondence and communication while using our services
- Phone Number - We may collect your phone number in order to contact you
- IP Address - We may collect your IP address in order to verify your location and monitor trends

- Cookies - We may store cookies in order to monitor search trends and to improve upon your user experience
- Site Metrics - We may monitor your site path, timestamps, page visits, and additional analytical metrics
- Payment Information - Through our payment platform, PayPal, we may collect and store your payment information for transactions
- Your Content - We may collect your content such as any comments, original content, or information entered into our website
